VACCINE SAFETY: THE UNITED STATES ON THE RIGHT TRACK
President Trump and Secretary of Health Kennedy held a press conference on
September 22, 2025, during which numerous commitments were announced.
E3M responds to the comments made in its area of expertise: vaccine safety,
and in particular the neurotoxicity of aluminum-based adjuvants.

CONTINUE THE POLICY OF BURYING OUR HEADS IN THE SAND OR DECIDE TO TAKE ACTION?

Faced with the explosion in cases of autism and numerous chronic diseases, there are two ways to react: **close our eyes and** ears and abandon the victims to their fate, or seek to understand what may be causing these conditions.

There are probably multiple causes for these pathologies, and industrial agriculture is logically implicated due to its use of toxic products. The French are aware of this, as shown by the <u>massive support for the petition</u> against the Duplomb Law. But health products are also under scrutiny.

The US government has the courage to question its vaccination policy. This will not please the pharmaceutical industry and its mouthpieces in the media (see <u>our open letter</u> to France Culture, and the two related reports: <u>Review of scientific knowledge on aluminum-based adjuvants</u> and <u>The conflicts of interest of Infovac experts</u>).

- Yes, the US is right to want to end vaccination in **the first hours** of a child's life, particularly against hepatitis B (<u>Gallagher</u> and Goodman 2010).
- Yes, no vaccine should contain toxic substances, particularly mercury or aluminum compounds. The latest publication by
 the French expert team on aluminum-based adjuvants shows that the determination of the amount of aluminum in
 vaccines is not based on any safety data (Angrand, Gherardi, Crepeaux 2025, <u>original version</u> <u>French version</u>).
- Yes, there are alternative adjuvants, such as microcrystalline tyrosine (<u>Leuthard 2018</u>) or calcium phosphate, considered a "biodegradable adjuvant" by some researchers (<u>see the 2015 E3M report</u> and the 2017 publication by Masson et al. <u>Calcium phosphate: a substitute for aluminum adjuvants?</u>). These alternatives, which E3M has been advocating for more than 10 years, have been confirmed by a recent publication (<u>Pérez, Lujan et al., 2025</u>), which concludes: "This work is the first to demonstrate the effectiveness of biocompatible alternative adjuvants in vaccines for sheep."

FOR E3M, THE NEXT STEP SHOULD FOCUS ON THESE THREE OBJECTIVES:

- Determine the damage caused by the injection of these toxic compounds.
- Find **treatments** that provide real care for patients (currently abandoned).
- Compensate them for the harm suffered.

AND IN FRANCE, WHAT ARE THE OPTIONS?

- French health authorities now have a choice: either they cling to their convictions, which are contradicted by science independent of the pharmaceutical industry, or they have the clarity of mind to join this courageous initiative from the US.
- French journalists are also concerned by this necessary and inevitable introspection. They have a duty to apply the Munich Charter of Ethics ("Respect the truth, whatever the consequences for oneself, because of the public's right to know the truth Never confuse the profession of journalist with that of advertiser or propagandist").

It is time to reaffirm that Science without conscience is but the ruin of the soul (Rabelais - 1483-1553).
